For large spills provide diking or other appropriate containment to keep material from spreading. If diked material can be pumped, store recovered material in appropriate container. Clean area as appropriate since some silicone material, even in small quantities, may present a slip hazard. Final cleaning may require steam, solvents or detergents.

SECTION 7. HANDLING AND STORAGE

Handling: Avoid eye contact.

Storage: Keep container tightly closed and away from oxidizing materials.

SECTION 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Engineering Controls:
